CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LAWRENCE MORSE  
ROUTE 1 BOX 239  
ENTERPRISE, OREGON 97828

confirms the right to use the waters of WELLS 2 & 3 in the UMATILLA RIVER BASIN for the purpose of SUPPLEMENTAL IRRIGATION OF 161.1 ACRES.

The right has been perfected under Permit G-9648. The date of priority is AUGUST 3, 1981. The right is limited to not more than 1.96 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

NE 1/4 SE 1/4, SECTION 14, AND SE 1/4 SE 1/4, SECTION 12, T 4 N, R 29 E, W.M.; WELL 2 - 1450 FEET NORTH AND 730 FEET WEST FROM THE SE CORNER OF SECTION 14, WELL 3 - 1000 FEET NORTH AND 60 FEET WEST FROM THE SE CORNER OF SECTION 12.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 SW 1/4 20.4 ACRES  
SE 1/4 SW 1/4 39.0 ACRES  
SW 1/4 SE 1/4 39.0 ACRES  
SE 1/4 SE 1/4 35.8 ACRES

NW 1/4 NW 1/4 13.0 ACRES

TOWNSHIP 4 NORTH, RANGE 29 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
