## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of FOUR WELLS in the PALMER CREEK BASIN for the purpose of SUPPLEMENTAL IRRIGATION OF 90.1 ACRES.

The right has been perfected under Permit G-8823. The date of priority is APRIL 25, 1979. The right is limited to not more than 0.22 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 67, SE 1/4 NW 1/4, NE 1/4 SW 1/4, BOTH AS PROJECTED WITHIN DLC 64, SECTION 29, T 5 S, R 3 W, W.M.; WELL 1 - 1400 FEET SOUTH AND 1780 FEET EAST, WELL 2 - 2860 FEET SOUTH AND 2450 FEET EAST, WELL 3 - 2400 FEET SOUTH AND 1740 FEET EAST, WELL 4 - 3290 FEET SOUTH AND 1470 FEET EAST, ALL FROM THE NW CORNER OF SECTION 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein, and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
