CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of PALMER CREEK AND A RESERVOIR CONSTRUCTED UNDER PERMIT R-952, WITH ANY DEFICIENCY TO BE APPROPRIATED FROM RESERVOIR 2, CONSTRUCTED UNDER PERMIT R-1308 AND ENLARGEMENT UNDER PERMITS R-4596 AND R-5610, all tributaries of YAMHILL RIVER, for the purpose of IRRIGATING 90.1 ACRES.

The right has been perfected under Permit 44780. The date of priority is APRIL 25, 1979. The right is limited to not more than 1.13 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 NE 1/4, AS PROJECTED WITHIN DLC 49, SECTION 30, AND NE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 67, SECTION 29, T 5 S, R 3 W, W.M.; PALMER CREEK & RESERVOIR 1 - 1100 FEET SOUTH AND 250 FEET WEST, RESERVOIR 2 - 1300 FEET SOUTH AND 1650 FEET EAST, BOTH FROM THE NW CORNER OF SECTION 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
