CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That MRS. SARAH J. NEWSOM of Prineville State of Oregon has a right to the use of the waters of Newsom Creek, a tributary of Crooked River,

for the purpose of the irrigation of 164.9 acres of land, and stock and domestic use,

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Crook County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 1, at page 449; that the priority of the right hereby confirmed dates from the year 1874 for the irrigation of 3 acres in Tract No. 1; from 1880 for 22 acres in Tract No. 1; from 1890 for 25 acres in Tract No. 1; from 1900 for 103.9 acres in Tract No.1; from 1877 for the irrigation of lands in Tract No. 2;

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purpose, and shall not exceed a reasonable amount for stock and domestic use, and 2.08 cubic feet per second for irrigation, the total quantity being limited to four acre feet per acre during each year. The use hereunder shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

153.9 acres in Tract No. 1, located as follows: 13 acres in the SE 1/4 of SE 1/4; Section Seven (7): 20 acres in the SW 1/4 of SW 1/4; Section Eight (8): 17.1 acres in the NW 1/4 of NW 1/4; Section Seventeen (17): 18.5 acres in the NE 1/4 of NE 1/4; 2 acres in the NW 1/4 of NE 1/4; 16.9 acres in the SW 1/4 of NE 1/4; 35 acres in the SE 1/4 of NE 1/4; 1.3 acres in the SE 1/4 of SE 1/4; Section Eighteen (18): 15.1 acres in the NE 1/4 of NE 1/4; 15 acres in the SE 1/4 of NE 1/4; Section Nineteen (19): all in Township Seventeen (17) South Range Nineteen (19) East of Willamette Meridian, in Crook County, Oregon.

11 acres in Tract No. 2, located as follows: 11 acres in the NE 1/4 of SE 1/4; Section Eighteen (18) Township Seventeen (17) South Range Nineteen (19) East of Willamette Meridian, in Crook County, Oregon.
