CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of TWO WELLS (14 FEET APART) in the DREWS CREEK BASIN for the purpose of PRIMARY IRRIGATION OF 118.7 ACRES AND SUPPLEMENTAL IRRIGATION OF 270.6 ACRES.

The right has been perfected under Permit G-8648. The date of priority is FEBRUARY 3, 1978. The right is limited to not more than 4.87 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

NW 1/4 SE 1/4, SECTION 19, T 40 S, R 19 E, W.M.; WELL 2-108 FEET NORTH AND 105.3 FEET EAST, WELL 4 - 94 FEET NORTH AND 107 FEET EAST, BOTH FROM THE SW CORNER OF NW 1/4 SE 1/4, SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
