CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of BUTTER CREEK, a tributary of the UMATILLA RIVER, for the purpose of IRRIGATING 105.5 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at page 250. The date of priority is 1877.

The right is limited to not more than 1.74 CUBIC FEET PER SECOND, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION.

The points of diversion are located as follows:

NW 1/4 SE 1/4, SECTION 23, SE 1/4 NE 1/4, SECTION 15, T 1 N, R 27 E, W.M.; SOUTH 86 DEGREES, 15 MINUTES EAST, 3230 FEET FROM THE WEST 1/4 CORNER OF SECTION 23; 2760 FEET NORTH AND 550 FEET WEST FROM THE SE CORNER OF SECTION 23.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm an ADDITIONAL POINT OF DIVERSION approved by an order of the Water Resources Director entered JANUARY 21, 1980, and together with certificate 49074, supersedes certificate 48569, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
