CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WARREN POOLE

confirms the right to use the waters of A WELL in the MILL CREEK BASIN for the purpose of PRIMARY IRRIGATION OF 20.9 ACRES AND SUPPLEMENTAL IRRIGATION OF 6.9 ACRES.

The right has been perfected under Permit G-10737. The date of priority is AUGUST 5, 1986. The right is limited to not more than 0.35 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 NE 1/4, AS PROJECTED WITHIN DLC 38, SECTION 1, T 8 S, R 3 W, W.M.; 1320 FEET NORTH AND 250 FEET WEST FROM SW CORNER DLC 37.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. THE RIGHT IS FURTHER LIMITED TO APPROPRIATION OF WATER ONLY TO THE EXTENT THAT IT DOES NOT IMPAIR OR SUBSTANTIALLY INTERFERE WITH EXISTING SURFACE WATER RIGHTS OF OTHERS. The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
