## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ANDERSON LAND AND LIVESTOCK 43 S.E. THIRD STREET PENDLETON, OREGON 97801

confirms the right to use the waters of MCKAY CREEK, NORTH FORK MCKAY CREEK AND SOUTH FORK MCKAY CREEK, a tributary of UMATILLA RIVER, for the purpose of IRRIGATING 64.1 ACRES.

The right has been perfected under Permit 42032. The date of priority is AUGUST 5, 1977. The right is limited to not more than 0.81 CUBIC FOOT PER SECOND; BEING 0.48 CFS FROM MCKAY CREEK, 0.01 CFS FROM NORTH FORK MCKAY CREEK, AND 0.32 CFS FROM SOUTH FORK MCKAY CREEK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 SW 1/4, SECTION 4, T 1 S, R 33 E, W.M.; NW 1/4 NW 1/4, SECTION 6, NW 1/4 SW 1/4, SECTION 7, T 1 S, R 34 E, W.M.; MCKAY CREEK - 1950 FEET NORTH AND 1350 FEET WEST FROM THE SOUTH 1/4 CORNER OF SECTION 4; NORTH FORK - 450 FEET SOUTH AND 600 FEET EAST FROM THE NW CORNER OF SECTION 6; SOUTH FORK - 1740 FEET NORTH AND 20 FEET EAST FROM THE SW CORNER OF SECTION 7.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
