CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of NORTH FORK JOHN DAY RIVER, a tributary of JOHN DAY RIVER, for the purpose of IRRIGATING 32.0 ACRES.

The right has been perfected under Permit 33401. The date of priority is MARCH 29, 1968. The right is limited to not more than 0.80 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 NW 1/4, SECTION 9, T 9 S, R 27 E, W.M.; 5170 FEET SOUTH & 1430 FEET EAST FROM NW CORNER SECTION 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 NW 1/4 6.7 ACRES
NW 1/4 SW 1/4 22.1 ACRES
SECTION 4

NE 1/4 SE 1/4 3.2 ACRES
SECTION 5
TOWNSHIP 9 SOUTH, RANGE 27 EAST, W.M.

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered AUGUST 16, 1984, and together with certificate 52553, supersedes certificate 39966, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
