CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ORCHARDS WATER COMPANY BROGAN, OREGON 97903

confirms the right to use the waters of POLE CREEK, BLACK CREEK, AND RESERVOIR NO. 1 CONSTRUCTED UNDER PERMIT R-1364, tributaries of WILLOW CREEK, for the purpose of THE SUPPLEMENTAL IRRIGATION OF 1482.6 ACRES.

The right has been perfected under Permit 21494. The date of priority is NOVEMBER 24, 1950. The right is limited to not more than 37.1 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 SW 1/4, SECTION 27, NW 1/4 NW 1/4, SECTION 34, SE 1/4 NE 1/4, SECTION 22, T 15 S, R 42 E, W.M.; POLE CREEK - 110 FEET SOUTH AND 950 FEET EAST FROM W 1/4 CORNER SECTION 27, BLACK CREEK - 1260 FEET SOUTH AND 1310 FEET EAST FROM NW CORNER SECTION 34, RESERVOIR-2100 FEET SOUTH AND 1080 FEET WEST FROM NE CORNER SECTION 22, WILLOW CREEK RE-DIVERSIONS: NE 1/4 NE 1/4, SECTION 24, NE 1/4 NE 1/4, SECTION 25, T 15 S, R 42 E, W.M.; EASTSIDE DITCH - 830 FEET SOUTH 1320 FEET WEST FROM NE CORNER SECTION 24, PUMP - 20 FEET SOUTH AND 1000 FEET WEST FROM NE CORNER SECTION 25; SW 1/4 SE 1/4, SECTION 30, T 15 S, R 43 E, W.M. - 20 FEET NORTH AND 300 FEET EAST FROM S 1/4 CORNER SECTION 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
