confirms the right to use the waters of ELK RIVER AND AN UNNAMED STREAM, both tributaries of PACIFIC OCEAN, for the purpose of IRRIGATING 311.8 ACRES.

The right has been perfected under Permit 40646. The date of priority is MAY 17, 1976. The right is limited to not more than 3.89 CUBIC FEET PER SECOND; BEING 0.48 CFS FROM ELK RIVER AND 3.41 CFS FROM THE UNNAMED STREAM, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 SE 1/4, SECTION 17, SW 1/4 NE 1/4, SW 1/4 SE 1/4, BOTH AS PROJECTED WITHIN DLC 38, SECTION 18, T 32 S, R 15 W, W.M.; RIVER - 3300 FEET SOUTH AND 1550 FEET WEST FROM THE NE CORNER OF SECTION 17, UNNAMED STREAM - 1180 FEET NORTH AND 1740 FEET WEST FROM THE SE CORNER OF SECTION 18, - 1750 FEET SOUTH AND 1780 FEET WEST FROM THE NE CORNER OF SECTION 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
