## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CRAIG A. SNYDER
ROUTE 1, BOX 7
TYGH VALLEY, OREGON, 97063

confirms the right to use the waters of AN UNNAMED DRAW AND A RESERVOIR CONSTRUCTED UNDER PERMIT R-8139 AND INCLUDES SUPPLEMENTAL STORAGE UNDER PERMIT R-8502, both tributaries of WHITE RIVER, for the purpose of SUPPLEMENTAL IRRIGATION OF 165.0 ACRES.

The right has been perfected under Permit 47033. The date of priority is JANUARY 26, 1982. The right is limited to not more than 2.0 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 SW 1/4, SECTION 24, T 4 S, R 12 E, W.M.; UNNAMED DRAW - 470 FEET SOUTH AND 710 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 24; AND SE 1/4 NW 1/4, SECTION 19, T 4 S, R 13 E, W.M.; RESERVOIR-1350 FEET SOUTH AND 120 FEET WEST FROM THE NORTH 1/4 CORNER OF SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
