CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN AND RUTH FULTON
3865 FIFTEEN MILE ROAD
THE DALLES, OREGON 97058

confirms the right to use the waters of EIGHTMILE CREEK AND A SPRING, both tributaries of FIFTEEN MILE CREEK, for the purpose of PRIMARY IRRIGATION OF 7.5 ACRES, SUPPLEMENTAL IRRIGATION OF 18.2 ACRES, AND LIVESTOCK.

The right has been perfected under Permit 45361. The date of priority is SEPTEMBER 22, 1980. The right is limited to not more than 0.325 CUBIC FOOT PER SECOND, BEING 0.005 CFS FOR LIVESTOCK, AND 0.32 CFS FOR IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 SW 1/4, SW 1/4 SW 1/4, SECTION 4, T 1 N, R 14 E, W.M.; CREEK - 300 FEET SOUTH AND 1790 FEET WEST; SPRING - 1900 FEET SOUTH AND 1450 FEET WEST; BOTH FROM THE CENTER 1/4 CORNER OF SECTION 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
