## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DAVID JOHN STOUT, SR. 47510 PACIFIC VIEW LANGLOIS, OREGON 97450

confirms the right to use the waters of JIM CREEK, a tributary of FLORAS CREEK, for the purpose of IRRIGATING 5.8 ACRES AND DOMESTIC USE FOR TWO FAMILIES.

The right has been perfected under Permit 46235. The date of priority is DECEMBER 3, 1981. The right is limited to not more than 0.065 CUBIC FOOT PER SECOND, BEING 0.06 CFS FOR IRRIGATION AND 0.005 CFS FOR DOMESTIC USE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SW 1/4, SECTION 11, T 31 S, R 15 W, W.M.; 810 FEET NORTH AND 1140 FEET EAST FROM THE SW CORNER OF SECTION 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 SW 1/4 5.8 ACRES AND DOMESTIC SECTION 11
TOWNSHIP 31 SOUTH, RANGE 15 WEST, W.M.

AN ERROR OCCURRED WHEN PROCESSING THE APPLICATION WHICH LEAD TO ISSUANCE OF A PERMIT FOR LESS THAN THE ALLOWABLE RATE AND LESS THAN THE APPLICANT ORIGINALLY REQUESTED. THIS CERTIFICATE IS ISSUED AS THOUGH THE APPLICATION WERE CORRECTLY PROCESSED AND THE PERMIT WAS ISSUED FOR THE ALLOWABLE RATE.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
