CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of HASKINS RESERVOIR CONSTRUCTED UNDER PERMIT R-612 AND ENLARGED UNDER PERMIT R-8885, a tributary of NORTH YAMHILL RIVER, for the purpose of MUNICIPAL USE.

The right has been perfected under Permit 47779. The date of priority is DECEMBER 15, 1981. The right is limited to not more than 355 ACRE-FEET OF STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NW 1/4, SECTION 18, T 3 S, R 5 W, W.M.; 380 FEET NORTH AND 1100 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 18.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
