CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES PIERCE PETITTI

confirms the right to use the waters of AN UNNAMED DRAINAGEWAY, 2 SPRINGS AND PETITTI RESERVOIR CONSTRUCTED UNDER PERMIT R-8595, all tributaries to LITTLE LUCKIAMUTE RIVER, for the purpose of FISH CULTURE AND DOMESTIC USE FOR ONE FAMILY.

The right has been perfected under Permit 47321. The date of priority is DECEMBER 28, 1982. The right is limited to not more than 6.5 GPM; BEING 2 GPM FROM SPRING AA FOR DOMESTIC USE AND 4.5 GPM FROM THE UNNAMED DRAINAGEWAY AND RESERVOIR WITH ANY DEFICIENCY MADE UP FROM SPRING AREA CC FOR FISH, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 NE 1/4 AS PROJECTED WITHIN DLC 42, NE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 43, SECTION 14, T 9 S, R 6 W, W.M.; SPRING AA-200 FEET NORTH AND 500 FEET EAST, SPRING CC - 350 FEET NORTH, UNNAMED DRAINAGE WAY AND RESERVOIR - 650 FEET NORTH AND 170 FEET WEST, ALL FROM THE SE CORNER OF DLC 43.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NW 1/4 NE 1/4 DOMESTIC  
AS PROJECTED WITHIN DLC 42  
NE 1/4 NW 1/4 FISH CULTURE  
AS PROJECTED WITHIN DLC 43  
SECTION 14  
TOWNSHIP 9 SOUTH, RANGE 6 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
