confirms the right to use the waters of A WELL in the DESCHUTES RIVER BASIN for the purpose of IRRIGATING 278.1 ACRES.

The right has been perfected under Permit G-9555. The date of priority is FEBRUARY 3, 1982. The right is limited to not more than 3.48 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 NE 1/4, SECTION 19, T 4 S, R 14 E, W.M.; 1850 FEET SOUTH AND 1040 FEET WEST FROM THE NE CORNER OF SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
