CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of LUCKIAMUTE RIVER AND LITTLE LUCKIAMUTE RIVER, a tributary of WILLAMETTE RIVER, for the purpose of IRRIGATING 199.9 ACRES.

The right has been perfected under Permit 41568. The date of priority is APRIL 2, 1973, FOR 0.85 CUBIC FOOT PER SECOND FROM THE LUCKIAMUTE RIVER AND JUNE 20, 1975, FOR 0.28 CFS FROM THE LUCKIAMUTE RIVER AND 1.37 CFS FROM THE LITTLE LUCKIAMUTE RIVER. The right is limited to not more than 2.5 CFS, BEING 1.13 CFS FROM THE LUCKIAMUTE RIVER AND 1.37 CFS FROM THE LITTLE LUCKIAMUTE RIVER, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 SW 1/4, AS PROJECTED WITHIN DLC 50, SECTION 8, SW 1/4 SE 1/4, AS PROJECTED WITHIN DLC 56, SECTION 17, T 9 S, R 5 W, W.M.; LITTLE LUCKIAMUTE RIVER - 75 FEET NORTH AND 370 FEET EAST FROM THE SW CORNER OF DLC 50; LUCKIAMUTE RIVER 950 FEET NORTH AND 1000 FEET EAST FROM THE SE CORNER OF DLC 56.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
