CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of RESERVOIR 3, constructed under permit R-8166, a tributary of SALT CREEK, for the purpose of SUPPLEMENTAL IRRIGATION OF 475.9 ACRES.

The right has been perfected under Permit 45015. The date of priority is SEPTEMBER 20, 1979. The right is limited to not more than 74.0 ACRE FEET OF STORED WATER ONLY.

The point of diversion is located as follows:

SE 1/4 SW 1/4, AS PROJECTED WITH DLC 75, SECTION 29, T 5 S, R 4 W, W.M.; 1140 FEET NORTH AND 2000 FEET EAST FROM THE SW CORNER OF SECTION 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of 2.5 ACRE-FEET per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
