## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SOUTHERN OREGON TALLOW COMPANY, INC. P. O. BOX 244 EAGLE POINT, OREGON 97524

confirms the right to use the waters of LOST CREEK RESERVOIR, CONSTRUCTED UNDER PERMIT R-8142, a tributary of ROGUE RIVER, for the purpose of SUPPLEMENTAL IRRIGATION OF 22.7 ACRES.

The right has been perfected under Permit 46092. The date of priority is AUGUST 27, 1981. The right is limited to not more than 45.0 ACRE FEET STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 NW 1/4, SECTION 7, T 36 S, R 1 W, W.M.; 500 FEET SOUTH AND 3900 FEET WEST FROM THE NE CORNER OF SECTION 7. LOST CREEK DAM - NW 1/4 SW 1/4, SECTION 26, T 33 S, R 1 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is subject to the terms and conditions of Contract No. 1-07-10-W0410, or a satisfactory replacement, between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 SE 1/4 6.4 ACRES NW 1/4 SE 1/4 7.2 ACRES SW 1/4 SE 1/4 8.4 ACRES SE 1/4 SE 1/4 0.7 ACRE SECTION 6

TOWNSHIP 36 SOUTH, RANGE 1 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
