CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN W. JACOBS
1630 SLATE CREEK ROAD
WILDERVILLE, OREGON 97543

confirms the right to use the waters of the LEFT FORK AND RIGHT FORK OF SLATE CREEK, a tributary of APPLGATE RIVER, for the purpose of PRIMARY AND SUPPLEMENTAL IRRIGATION OF 16.3 ACRES, DOMESTIC USE AND LIVESTOCK.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 16, at page 523. The date of priority is 1885 FOR 7.6 ACRES FROM THE LEFT FORK OF SLATE CREEK AND 1903 FOR 16.3 ACRES FROM THE RIGHT FORK OF SLATE CREEK.

The right is limited to not more than 0.33 CUBIC FOOT PER SECOND FROM THE RIGHT FORK OF SLATE CREEK AND 0.15 CFS FROM THE LEFT FORK OF SLATE CREEK. NOT TO EXCEED A TOTAL OF 0.33 CFS FROM BOTH SOURCES IF AVAILABLE AT THE ORIGINAL POINTS OF DIVERSION.

The points of diversion are located as follows:

LEFT FORK (ORIGINAL): SW 1/4 SE 1/4, SECTION 12, T 37 S, R 8 W, W.M.; NW 1/4 NW 1/4, SECTION 18, T 37 S, R 7 W, W.M.; RIGHT FORK: (ORIGINAL) SE 1/4 NE 1/4, SECTION 12, T 37 S, R 8 W, W.M.; (ADDITIONAL) SW 1/4 SW 1/4, SECTION 7, T 37 S, R 7 W, W.M.; 500 FEET NORTH AND 200 FEET EAST FROM THE SW CORNER OF SECTION 7.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FIFTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated. The right for supplemental use is limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered NOVEMBER 3, 1983, and supersedes certificate 45667, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
