CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of JOHN DAY RIVER, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATING 31.2 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for GRANT County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at page 461. The date of priority is 1890.

The right is limited to not more than 0.78 CUBIC FOOT PER SECOND IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION.

The point of diversion is located as follows:

SW 1/4 NE 1/4, SECTION 16, T 8 S, R 19 E, W.M.; 2060 FEET SOUTH AND 2400 FEET WEST FROM THE NE CORNER OF SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from April 1 to September 30, and shall be further limited to a diversion of one acre-foot per acre per calendar month; not to exceed five acre-feet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 NE 1/4	12.7 ACRES
SE 1/4 NE 1/4	1.7 ACRES
NE 1/4 SE 1/4	3.0 ACRES
NW 1/4 SE 1/4	13.8 ACRES

SECTION 16
TOWNSHIP 8 SOUTH, RANGE 19 EAST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered JULY 20, 1983 and supersedes certificate 45124, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
