CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LILLIAN LINDHORST
ROUTE 1, BOX 181
DUFUR, OREGON, 97021

confirms the right to use of waters of FIFTEENMILE CREEK, a tributary of COLUMBIA RIVER, for the purpose of IRRIGATING 3.2 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for WASCO County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 7, at page 406. The date of priority is 1875.

The right is limited to not more than ONE ACRE FOOT PER ACRE DURING ANY 30 DAY PERIOD UP TO JULY 1st OF EACH YEAR AND THEREAFTER NOT TO EXCEED THREE-FOURTHS ACRE FOOT PER ACRE DURING ANY 30 DAY PERIOD IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION, (ROBERTS DITCH) NW 1/4 SE 1/4, SECTION 1, T 2 S, R 12 E, W.M.

The point of diversion is located as follows:

SE 1/4 NE 1/4 SECTION 1, T 2 S, R 12 E, W.M.; 290 FEET NORTH & 200 FEET WEST FROM THE E 1/4 CORNER OF SECTION 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre AFTER JULY 1st, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each irrigated during the irrigation season of each year.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 NE 1/4 3.2 ACRES
SECTION 1
TOWNSHIP 2 SOUTH RANGE 12 EAST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered SEPTEMBER 15, 1978, and together with certificate 46843, supersedes certificate 40410, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
