confirms the right to use the waters of A SPRING, a tributary of COLUMBIA RIVER, for the purpose of IRRIGATING 1.6 ACRES AND MAINTENANCE OF A FISH POND.

The right has been perfected under Permit 24611. The date of priority is NOVEMBER 23, 1956. The right is limited to not more than 0.22 CUBIC FOOT PER SECOND, BEING 0.02 CFS FOR IRRIGATION AND 0.20 CFS FOR POND MAINTENANCE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 1 (NE 1/4 SE 1/4), SECTION 17, T 2 N, R 13 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80 of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

LOT 2 (NW 1/4 SW 1/4)      0.3 ACRE AND FISH  
SECTION 16  
LOT 1 (NE 1/4 SE 1/4)      1.3 ACRES  
SECTION 17  
TOWNSHIP 2 NORTH, RANGE 13 EAST, W.M.

This certificate is issued to confirm a change in USE AND PLACE OF USE approved by an order of the Water Resources Director entered MARCH 16, 1984, and supersedes certificate 27290, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
