## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN E. FISHER DAYVILLE, OREGON 97825

confirms the right to use the waters of the JOHN DAY RIVER, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATING 9.0 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for GRANT County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at page 461. The date of priority is 1880.

The right is limited to not more than 0.23 CUBIC FOOT PER SECOND, if available at the original point of diversion.

The points of diversion are located as follows:

SW 1/4 SW 1/4, SECTION 36, T 12 S, R 26 E, W.M.; LOT 3 (NE 1/4 NW 1/4), SECTION 1, T 13 S, R 26 E, W.M.; # 3 - 450 FEET NORTH AND 1580 FEET WEST; # 4 - 60 FEET SOUTH AND 1030 FEET WEST, BOTH FROM THE NORTH 1/4 CORNER OF SECTION 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre irrigated from April 1 to September 30, further limited to one acrefoot per acre per calendar month to July 1 and three-fourths acrefoot per acre thereafter, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5.0 acrefeet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 SW 1/4 7.8 ACRES SECTION 36 TOWNSHIP 12 SOUTH, RANGE 26 EAST, W.M.

NE 1/4 NW 1/4 1.2 ACRES SECTION 1 TOWNSHIP 13 SOUTH, RANGE 26 EAST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered MARCH 17, 1976, and supersedes certificate 25837, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
