CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILLIAM EVAN GILDOW
STAR ROUTE, BOX 385
FOREST GROVE, OREGON 97116

confirms the right to use the waters of GALES CREEK, a tributary of TUALATIN RIVER, for the purpose of IRRIGATING 23.6 ACRES.

The right has been perfected under Permit 41925. The date of priority is MAY 13, 1977. The right is limited to not more than 0.26 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 60, SECTION 17, T 1 N, R 4 W, W.M.; 720 FEET EAST FROM THE NW CORNER OF SECTION 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 SE 1/4 0.9 ACRE
SE 1/4 SE 1/4 2.3 ACRES
BOTH AS PROJECTED WITHIN DLC 60
SECTION 7
NW 1/4 SW 1/4 2.3 ACRES
SW 1/4 SW 1/4 18.1 ACRES
BOTH AS PROJECTED WITHIN DLC 60
SECTION 8
TOWNSHIP 1 NORTH, RANGE 4 WEST, W.M.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered NOVEMBER 2, 1984 and also includes the balance of the right affirmed by the final proof for Permit 41925.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
