confirms the right to use the waters of the JOHN DAY RIVER, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATING 15.9 ACRES.

The right has been perfected under Permit 28944. The date of priority is JUNE 25, 1963. The right is limited to not more than 0.40 CUBIC FOOT PER SECOND, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NW 1/4, SECTION 20, T 13 S, R 29 E, W.M.; 370 FEET NORTH AND 1290 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right to use of water is limited to the period when the flow of the John Day River is more than 30 cfs at USGS Gage No. 14-0465 and more than 20 cfs at USGS Gage No. 14-0480.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 NE 1/4 4.8 ACRES NE 1/4 SE 1/4 0.7 ACRE SECTION 19

SW 1/4 NW 1/4 6.8 ACRES

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered NOVEMBER 29, 1978, and together with certificate 47277 supersedes certificate 36753, State Record of Water Right Certificates.
