CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

EUGENE LA FORCE 400 ROBINSON CORNERS ROAD CAVE JUNCTION, OREGON 97523

confirms the right to use the waters of SUCKER CREEK, a tributary of the EAST FORK OF ILLINOIS RIVER, for the purpose of IRRIGATING 101.0 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for JOSEPHINE County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volumes 1 and 5, at pages 254 and 399 respectively. The dates of priority are 1889 FOR TRACT #1 AND 1908 FOR TRACT #2.

The right is limited to not more than 1.64 CUBIC FEET PER SECOND, BEING 1.02 CFS FOR TRACT #1 AND 0.62 CFS FOR TRACT #2, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION. THE USE OF WATER SHALL BE CONFINED TO THE SEASON APRIL 1 TO OCTOBER 31 OF EACH YEAR.

The point of diversion is located as follows:

NE 1/4 NE 1/4, SECTION 28, T 39 S, R 7 W, W.M.; 60 FEET SOUTH AND 930 FEET WEST FROM THE NE CORNER OF SECTION 28.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered MAY 9, 1980, and together with certificate 49704, supersedes certificate 7162, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
