confirms the right to use the waters of the JOHN DAY RIVER, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATING 40.0 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for GRANT County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at page 461. The date of priority is 1883.

The right is limited to not more than 1.0 CUBIC FOOT PER SECOND IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION.

The points of diversion are located as follows:

SW 1/4 NE 1/4, SECTION 30, NW 1/4 SW 1/4, SECTION 20, T 11 S, R 26 E, W.M.; 1 - 1650 FEET SOUTH AND 2100 FEET WEST; 2 - 2350 FEET NORTH AND 190 FEET EAST; BOTH FROM THE SW CORNER OF SECTION 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from April 1 to September 30, and shall be further limited to a diversion of one acre-foot per acre per calendar month, not to exceed a total of five acre-feet for each acre irrigated during the irrigation season of each year.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
