CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PHYLLIS MCCARTHY
PRAIRIE CITY, OREGON 97869

confirms the right to use the waters of the JOHN DAY RIVER, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATING 1.6 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for GRANT County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at page 461. The date of priority is 1869.

The point of diversion is located as follows:

NE 1/4 NW 1/4, SECTION 11, T 13 S, R 33 E, W.M.; 230 FEET SOUTH AND 50 FEET WEST FROM THE SW CORNER OF BLOCK C OF BRADFORD LAYCOCK ADDITION TO PRAIRIE CITY.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH CUBIC FOOT PER SECOND PER ACRE IRRIGATED FROM APRIL 1 TO SEPTEMBER 30; FURTHER LIMITED TO 1.0 ACRE-FOOT PER ACRE PER CALENDAR MONTH TO JULY 1 AND 0.75 ACRE-FOOT PER ACRE THEREAFTER; TOTAL FIVE ACRE-FEET PER ACRE FOR THE IRRIGATION SEASON OF EACH YEAR. THIS RIGHT IS FURTHER LIMITED TO THE QUANTITY OF WATER AVAILABLE AT THE ORIGINAL POINT OF DIVERSION.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 NW 1/4 1.6 ACRES
SECTION 11
TOWNSHIP 13 SOUTH, RANGE 33 EAST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered JULY 21, 1980, and together with certificate 49671, supersedes certificate 25451, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
