## CERTIFICATE OF WATER RIGHT

This is to Certify, That ISABELLE HUTCHINSON

of Union, State of Oregon has a right to the use of

the waters of Little Creek for Tract No. 1; Catherine Creek for Tracts Nos. 2, 3 and 4; for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Union County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 8, at page 1; that the priority of the right thereby confirmed dates from 1863 for Tract No. 1; 1867 for Tract No. 2; 1885 for Tract No. 3, and Sept. 6, 1898 for Tract No. 4.

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed Three acre feet per acre in any irrigation season, diverted at a rate of not to exceed one-fortieth of a cubic foot per second per acre;

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

**Tract No. 1:** Twenty (20) acres in the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$ ), Twenty (20) acres in the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ NE $\frac{1}{4}$ ), Section Eighteen (18), Twenty (20) acres in the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$ ), Section Seven (7), Township 4 South, Range 40 East of the Willamette Meridian, being a total of 60 acres.

(NOTE: The land in Section 7 has a supplementary right from Catherine Creek through Swackhamer-Hutchinson-Schoonover ditch, under priority date of September 6th, 1898, in addition to lands hereinafter described as under said ditch.)

**Tract No. 2:** Ten (10) acres in the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$ ), Twenty (20) acres in the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$ ), Fifteen and one tenth (15.1) acres in the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$ ), Forty (40) acres in the Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$ ), Forty (40) acres in the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ NE $\frac{1}{4}$ ), Section Fourteen (14), Twenty-three (23) acres in the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$ ), Thirty (30) acres in the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$ ), Section 23, T. 4 S.R. 39 E.W.M., being a total of 178.1 acres.

**Tract No. 3:** Twenty (20) acres in the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$ ), Twenty (20) acres in the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$ ), Four and three tenths (4.3) acres in the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$ ), Section 14, T. 4 S.R. 39 E.W.M., being a total of 44.3 acres.

**Tract No. 4:** Twenty (20) acres in the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$ ), Twenty-nine (29) acres in the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$ ), Section 7, T. 4 S.R. 40 E.W.M., being a total of 49 acres.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described. And said right shall be subject to all other conditions and limitations contained in said decree.
