confirms the right to use the waters of WELLS #1 AND #2 in the FORT ROCK BASIN for the purpose of IRRIGATING 222.9 ACRES.

The right has been perfected under Permit G-9347. The date of priority is JULY 15, 1980. The right is limited to not more than 2.79 CUBIC FEET PER SECOND; BEING 1.19 CFS FROM WELL #1 AND 1.60 CFS FROM WELL #2 or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SE 1/4 NW 1/4, SE 1/4 SW 1/4, SECTION 6, T 27 S, R 18 E, W.M.; WELL #1 - 1300 FEET SOUTH AND 1250 FEET EAST FROM THE NW CORNER OF SECTION 6; WELL #2 - 1300 FEET NORTH AND 1300 FEET EAST FROM THE SW CORNER OF SECTION 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
