CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LARRY HAYS  
ROUTE 2, BOX 209A  
DAYTON, OREGON 97114

confirms the right to the use of the waters of UNNAMED STREAM AND HAYS RESERVOIR CONSTRUCTED UNDER PERMIT R-8148, a tributary of WILLAMETTE RIVER, for the purpose of THE PRIMARY IRRIGATION OF 19.5 ACRES, SUPPLEMENTAL IRRIGATION OF 1.5 ACRES, AND FISH CULTURE.

The right has been perfected under Permit 44945. The date of priority is FEBRUARY 11, 1979 FOR 0.04 CUBIC FOOT PER SECOND FOR IRRIGATION, OCTOBER 17, 1979 FOR 0.20 CFS FOR IRRIGATION, 0.02 CFS FOR FISH CULTURE, AND STORED WATER ONLY FOR LANDS DESCRIBED AS SUPPLEMENTAL. The right is limited to not more than 0.26 cubic per second or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NE 1/4, SECTION 3, T 4 S, R 3 W, W.M.; 130 FEET NORTH AND 880 FEET EAST FROM THE CENTER OF SECTION 3.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SECTION 3  
TOWNSHIP 4 SOUTH, RANGE 3 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
