CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICHARD L. SHARP
741 WEST JACKSON
MEDFORD, OREGON 97501

confirms the right to use the waters of the APPLIGATE RIVER, a tributary of the ROGUE RIVER, for the purpose of TEMPERATURE CONTROL AND SUPPLEMENTAL IRRIGATION OF 10.0 ACRES.

The right has been perfected under Permit 46488. The date of priority is AUGUST 17, 1981, FOR 0.125 CUBIC FOOT PER SECOND AND JANUARY 11, 1982, FOR 0.975 CFS. The right is limited to not more than 1.1 CUBIC FEET PER SECOND, BEING 1.1 CFS FOR TEMPERATURE CONTROL AND 0.125 CFS FOR SUPPLEMENTAL IRRIGATION, PROVIDED THE TOTAL DIVERSION DOES NOT EXCEED 1.1 CFS, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SW 1/4, AS PROJECTED WITHIN DLC 40, SECTION 28, T 38 S, R 3 W, W.M.; 550 FEET NORTH AND 3460 FEET WEST FROM THE SOUTHEAST CORNER OF SECTION 28.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 SE 1/4 10.8 ACRES
AS PROJECTED WITHIN DLC 40
SECTION 28
TOWNSHIP 38 SOUTH, RANGE 3 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
