CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of MCKENZIE RIVER, a tributary of WILLAMETTE RIVER, for the purpose of IRRIGATING 34.8 ACRES.

The right has been perfected under Permit 47223. The date of priority is AUGUST 25, 1982. The right is limited to not more than 0.44 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 5 (SW 1/4 NE 1/4), SECTION 15, T 17 S, R 3 W, W.M.; 1530 FEET NORTH AND 2020 FEET WEST, 960 FEET NORTH AND 1510 FEET WEST; BOTH FROM THE NE CORNER OF DLC 45.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

LOT 4 (NW 1/4 NE 1/4) 2.5 ACRES 11.3 ACRES LOT 5 (SW 1/4 NE 1/4) 0.7 ACRE SW 1/4 NE 1/4 AS PROJECTED WITHIN DLC 44 LOT 4 (NE 1/4 NW 1/4) 6.5 ACRES LOT 5 (SE 1/4 NW 1/4) 1.4 ACRES SE 1/4 NW 1/4 7.6 ACRES 2.5 ACRES NW 1/4 SE 1/4 BOTH AS PROJECTED WITHIN DLC 44 2.3 ACRES LOT 6 (NW 1/4 SE 1/4) SECTION 15 TOWNSHIP 17 SOUTH, RANGE 3 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
