CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of ALDER GULCH, a tributary of CANYON CREEK, and CANYON CREEK, a tributary of JOHN DAY RIVER, for the purpose of IRRIGATING 7.4 ACRES.

The right has been perfected under Permit 47239. The date of priority is NOVEMBER 26, 1982. The right is limited to not more than 0.19 CUBIC FOOT PER SECOND, BEING 0.03 CFS FROM ALDER GULCH WITH ANY DEFICIENCY IN SUPPLY FROM CANYON CREEK, AND 0.16 CFS FROM CANYON CREEK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 2 (SW 1/4 NW 1/4), SE 1/4 NW 1/4, NW 1/4 SE 1/4, SECTION 19, T 15 S, R 32 E, W.M.; NE 1/4 NE 1/4, SECTION 24, T 15 S, R 31 E, W.M.: ALDER GULCH - 440 FEET NORTH AND 470 FEET WEST; CANYON CREEK-800 FEET SOUTH AND 150 FEET EAST, BOTH FROM THE CENTER 1/4 SECTION 19; 1520 FEET SOUTH AND 1120 FEET EAST, 400 FEET SOUTH AND 870 FEET WEST BOTH FROM THE NE CORNER OF SECTION 24.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
