CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of SOUTH FORK JOHN DAY RIVER, a tributary of JOHN DAY RIVER, for the purpose of 19.9 ACRES PRIMARY IRRIGATION AND 2.3 ACRES SUPPLEMENTAL IRRIGATION.

The right has been perfected under Permit 47898. The date of priority is JULY 1, 1983. The right is limited to not more than 0.56 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 NW 1/4, LOT 2 (SW 1/4 NW 1/4), SECTION 18, T 13 S, R 27 E, W.M.; 1070 FEET SOUTH AND 620 FEET WEST FROM THE NORTH 1/4 CORNER OF SECTION 18; AND 970 FEET NORTH AND 600 FEET EAST, 350 FEET NORTH AND 170 FEET EAST, BOTH FROM THE WEST 1/4 CORNER OF SECTION 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
