CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TRAVIS C. AND HAZEL C. DICKSON 54470 S.W. HEBO ROAD GRAND RONDE, OREGON 97347

confirms the right to use the waters of A SPRING AND SOUTH YAMHILL RIVER, a tributary of YAMHILL RIVER, for the purpose of DOMESTIC USE FOR ONE FAMILY AND IRRIGATION OF 2.2 ACRES.

The right has been perfected under Permit 40297. The date of priority is APRIL 4, 1975, FOR IRRIGATION AND JUNE 12,,1975, FOR DOMESTIC USE. The right is limited to not more than 0.04 CUBIC FOOT PER SECOND; BEING 0.005 CFS FOR DOMESTIC AND 0.005 CFS FOR IRRIGATION FROM THE SPRING, AND 0.03 CFS FOR IRRIGATION FROM SOUTH YAMHILL RIVER, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 SE 1/4, SE 1/4 SE 1/4, SECTION 33, T 5 S, R 8 W, W.M.; SPRING - 2050 FEET NORTH AND 1110 FEET WEST; RIVER - 800 FEET NORTH AND 990 FEET WEST, BOTH FROM THE SE CORNER OF SECTION 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

<u>SPRING</u> <u>RIVER</u>

NE 1/4 SE 1/4 O.6 ACRE SE 1/4 SE 1/4 DOMESTIC & 0.1 ACRE 1.5 ACRES SECTION 33

TOWNSHIP 5 SOUTH, RANGE 8 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
