confirms the right to use the waters of FORKED HORN BUTTE WELL #4 in the DESCHUTES RIVER BASIN for the purpose of MUNICIPAL USE.

The right has been perfected under Permit G-10544. The date of priority is SEPTEMBER 25, 1985. The right is limited to not more than 6.90 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 SW 1/4, SECTION 20, T 15 S, R 13 E, W.M.; 520 FEET NORTH AND 1430 FEET EAST FROM THE SW CORNER OF SECTION 20.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
