CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FARM CREDIT BANK OF SPOKANE

SPOKANE, WASHINGTON 99220

confirms the right to use the waters of AN UNNAMED SLOUGH, a tributary of POWDER RIVER, for the purpose of SUPPLEMENTAL IRRIGATION OF 418.0 ACRES.

The right has been perfected under Permit 42470. The date of priority is APRIL 29, 1975. The right is limited to not more than 6.70 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SW 1/4, SECTION 11, T 7 S, R 39 E, W.M.; 450 FEET SOUTH & 500 FEET WEST FROM CENTER 1/4 CORNER OF SECTION 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
