CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of DETROIT RESERVOIR, constructed under permit R-1625, a tributary of NORTH SANTIAM RIVER, for the purpose of IRRIGATING 43.6 ACRES.

The right has been perfected under Permit 47553. The date of priority is FEBRUARY 11, 1983. The right is limited to not more than 109.0 ACRE-FEET OF STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 1 (NE 1/4 NE 1/4), LOT 3 (NE 1/4 NW 1/4), SECTION 22, T 9 S, R 1 E, W.M.; 250 FEET SOUTH AND 2770 FEET EAST; 520 FEET SOUTH AND 400 FEET EAST; BOTH FROM THE SW CORNER OF DLC 49.
DETROIT RESERVOIR: NW 1/4, SECTION 7, T 10 S, R 5 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of not to exceed 2.5 acre-feet per acre irrigated during the irrigation season of each year. This right is subject to the terms and conditions of Contract No. 3-07-10-W0476, or a satisfactory replacement, between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
