CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WILLIAM P. and ELIZABETH A. JAMESON

confirms the right to use the waters of CROOKED RIVER, a tributary of
DESCHUTES RIVER, for the purpose of IRRIGATING 32.3 ACRES.

The right has been perfected under Permit 14284. The date of
priority is APRIL 8, 1940. The right is limited to not more than 0.40
CUBIC FOOT PER SECOND, IF AVAILABLE AT THE ORIGINAL POINT OF
DIVERSION, or its equivalent in case of rotation, measured at the
point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SE 1/4, SECTION 18, T 16 S, R 18 E, W.M.; 330 FEET
NORTH AND 920 FEET WEST FROM THE SE CORNER OF SECTION 18.

The amount of water used for irrigation, together with the amount
secured under any other right existing for the same lands, shall be
limited to a diversion of ONE-EIGHTIETH of one cubic foot per second
per acre (or its equivalent) and 4.0 acre-feet for each acre irrigated
during the irrigation season of each year. The right shall conform to
such reasonable rotation system as may be ordered by the proper state
officer.

A description of the place of use under the right, and to which such
right is appurtenant, is as follows:

NW 1/4 SW 1/4 0.4 ACRE
SW 1/4 SW 1/4 1.7 ACRES
SECTION 17

NE 1/4 SW 1/4 2.6 ACRES
SE 1/4 SW 1/4 3.2 ACRES
SW 1/4 SE 1/4 11.2 ACRES
SE 1/4 SE 1/4 13.2 ACRES
SECTION 18

TOWNSHIP 16 SOUTH, RANGE 18 EAST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION
approved by an order of the Water Resources Director entered MARCH 23,
1983, and together with certificate 50894, supersedes certificate
24095, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the
status of the water right in regard to the provisions of ORS 540.610
pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted
to beneficial use on the lands or place of use described.
