## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FREDERICK K. ROBERTSON ROUTE 1, BOX 981 DAYVILLE, OREGON 97825

confirms the right to use the waters of the JOHN DAY RIVER, a tributary of the COLUMBIA RIVER, for the purpose of PRIMARY IRRIGATION OF 72.7 ACRES AND SUPPLEMENTAL IRRIGATION OF 38.3 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for GRANT County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at page 461. The date of priority is MARCH 14, 1906 FOR PRIMARY IRRIGATION AND 1906 FOR SUPPLEMENTAL IRRIGATION.

The right is limited to not more than 2.78 CUBIC FEET PER SECOND IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION.

The points of diversion are located as follows:

SW 1/4 NW 1/4, NW 1/4 SE 1/4, SECTION 12, T 13 S. R 27 E, W.M. 30 FEET NORTH AND 1060 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 12; 1386 FEET NORTH AND 1518 FEET WEST FROM THE SE CORNER OF SECTION 12.

LOT 1 (NW 1/4 NW 1/4), SECTION 18, T 13 S, R 28 E, W.M.; 560 FEET SOUTH AND 1250 FEET EAST FROM THE NW CORNER OF SECTION 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from April 1 to September 30, and shall be further limited to one acre-foot per acre per calendar month to July 1 and three-fourths acre-foot per acre thereafter; for a diversion of not to exceed five acre-feet per acre for each acre irrigated during the irrigation season of each year.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm ADDITIONAL POINTS OF DIVERSION approved by orders of the Water Resources Director entered JULY 6, 1976, AND NOVEMBER 30, 1981, APPROVING TRANSFERS 3378 AND 4861 and together with certificates 43751 and 52554, supersedes certificate 25851, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
