CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ESTATE OF MARY SILVERS WRIGHT AND ESTHER KENEALLY

confirms the right to use the waters of TWO SPRINGS, tributaries of WILLIAMSON RIVER, for the purpose of IRRIGATING 106.6 ACRES.

The right has been perfected under Permit 33408. The date of priority is JULY 24, 1968. The right is limited to not more than 1.57 CUBIC FEET PER SECOND, BEING 0.77 CFS FROM SPRING #1 AND 0.80 CFS FROM SPRING #2 or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 SW 1/4, SECTION 14, SW 1/4 SW 1/4, SECTION 11, T 34 S, R 7 E, W.M.; SPRING #1 - 800 FEET NORTH & 250 FEET EAST FROM THE SW CORNER OF SECTION 14; SPRING #2 - 460 FEET NORTH & 1260 FEET EAST FROM THE SW CORNER OF SECTION 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
