confirms the right to use the waters of the WILLAMETTE RIVER, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATING 5.5 ACRES.

The right has been perfected under Permit 43642. The date of priority is AUGUST 31, 1978. The right is limited to not more than 0.07 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 4 (SW 1/4 SE 1/4) SECTION 26; NE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 51, SECTION 27, T 4 S, R 3 W, W.M.; 1090 FEET SOUTH AND 3330 FEET EAST FROM THE NW CORNER OF LOT 13 (SW 1/4 SW 1/4), SECTION 26; 1180 FEET SOUTH AND 2230 FEET EAST FROM THE NW CORNER OF SECTION 27.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 NE 1/4 1.0 ACRE AS PROJECTED WITHIN DLC 51 SECTION 28

LOT 4 (SW 1/4 NE 1/4) 1.9 ACRES SECTION 33

LOT 1 (NE 1/4 NW 1/4) 1.9 ACRES LOT 7 (NW 1/4 NW 1/4) 0.7 ACRE SECTION 35

TOWNSHIP 4 SOUTH, RANGE 3 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
