CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WIL WILSON
ROUTE 1, BOX 244
DAYTON, OREGON 97114

confirms the right to use the waters of the WILLAMETTE RIVER BY DIVERSION FROM ADJACENT GRAVEL PITS, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATING 111.3 ACRES.

The right has been perfected under Permit 44392. The date of priority is JUNE 26, 1979. The right is limited to not more than 1.39 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 3 (NE 1/4 SW 1/4, LOT 4 (SE 1/4 SW 1/4), LOT 3 (NW 1/4 SE 1/4) SECTION 26, T 4 S, R 3 W, W.M.; 150 FEET NORTH AND 2370 FEET EAST, 900 FEET SOUTH AND 2270 FEET EAST, 1130 FEET NORTH AND 2710 FEET EAST, ALL FROM THE NW CORNER OF LOT 13 (SW 1/4 SW 1/4), SECTION 26.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

THIS RIGHT TO USE OF WILLAMETTE RIVER WATER BY A DIVERSION FROM ADJACENT GRAVEL PITS IS LIMITED TO THE APPROPRIATION OF THE DIRECT FLOW OF THE WATER OF WILLAMETTE RIVER. THIS RIGHT IS LIMITED TO APPROPRIATION ONLY TO THE EXTENT THAT IT DOES NOT INTERFERE WITH THE RIGHT TO USE OF GROUND WATER BY OTHERS.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
