CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LESTER S. AND MARGARET R. ROBERTS BOX 281 MOSIER, OREGON 97040

confirms the right to use the waters of AN UNNAMED STREAM AND SPRING #2, both tributaries of MOSIER CREEK, for the purpose of SUPPLEMENTAL IRRIGATION OF 16.4 ACRES AND LABOR CAMP USE.

The right has been perfected under Permit 49577. The date of priority is SEPTEMBER 27, 1985. The right is limited to not more than 0.25 CUBIC FOOT PER SECOND, BEING 0.23 CFS FROM THE UNNAMED STREAM FOR SUPPLEMENTAL IRRIGATION AND 0.02 CFS FROM THE SPRING FOR LABOR CAMP USE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 NE 1/4, SECTION 12, T 2 N, R 11 E, W.M.; SPRING - 240 FEET NORTH AND 720 FEET EAST; STREAM - 100 FEET NORTH AND 880 FEET EAST, BOTH FROM THE CENTER 1/4 CORNER OF SECTION 12.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-SIXTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NW 1/4 NE 1/4 0.3 ACRE SW 1/4 NE 1/4 16.1 ACRES AND LABOR CAMP USE SECTION 12 TOWNSHIP 2 NORTH, RANGE 11 EAST, W.M.

This certificate is issued to correctly describe the location and extent of use and supercedes certificate 64082, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
