CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LURLINE AND DELVIN McDANIEL  
ROUTE 2, BOX 216E  
PENDLETON, OREGON 97801

confirms the right to use the waters of BIRCH CREEK, a tributary of the UMATILLA RIVER, for the purpose of IRRIGATING 28.3 ACRES.

The right has been perfected under Permit 396. The date of priority is JULY 28, 1910. The right is limited to not more than 0.355 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 NE 1/4, NW 1/4 SE 1/4, SECTION 4, T 1 N, R 32 E, W.M.; SOUTH 62 DEGREES 41 MINUTES 3 SECONDS EAST 822 FEET; SOUTH 27 DEGREES 16 MINUTES 21 SECONDS EAST 2115 FEET; SOUTH 31 DEGREES 49 MINUTES 59 SECONDS EAST 2540 FEET; ALL FROM THE NW CORNER OF THE SW 1/4 NE 1/4 OF SECTION 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 NE 1/4	10.7 ACRES
SE 1/4 NE 1/4	4.1 ACRES
NE 1/4 SE 1/4	11.1 ACRES
NW 1/4 SE 1/4	2.4 ACRES

SECTION 4  
TOWNSHIP 1 NORTH, RANGE 32 EAST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered JULY 15, 1958, and together with certificates 64211 and 64212, supersedes certificate 1032, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
