CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WHITEHORSE RANCH  
FIELDS, OREGON 97710

confirms the right to use the waters of WILLOW CREEK WELL NO. 1, a tributary of WILLOW CREEK for the purpose of SUPPLEMENTAL IRRIGATION OF 619.5 ACRES.

The right has been perfected under Permit G-3. The date of priority is AUGUST 23, 1955. The right is limited to not more than 2.23 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW 1/4 SW 1/4, SECTION 15, T 37 S, R 36 E, W.M.; 2900 FEET SOUTH AND 4470 FEET WEST FROM THE NE CORNER, SECTION 15.

The amount of water used for supplemental irrigation, together with the amount secured under any other supplemental right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated. The total duty of water under all rights shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
