CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HAROLD S. HUBER AND JAMES E. BLOODSWORTH
ROUTE 2, BOX 2145
HEPPNER, OREGON 97836

confirms the right to use the waters of WILLOW CREEK, a tributary of COLUMBIA RIVER, for the purpose of IRRIGATING 30.4 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for MORROW County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 1, at page 73. The date of priority is 1890.

The right is limited to not more than 0.51 CUBIC FOOT PER SECOND, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION, SW 1/4 NE 1/4, SECTION 1, T 2 S, R 25 E, W.M.

The points of diversion are located as follows:

SW 1/4 SW 1/4, SECTION 36, T 1 S, R 25 E, W.M., SW 1/4 NE 1/4, SECTION 1, T 2 S, R 25 E, W.M.; POINT 1 - 560 FEET NORTH & 450 FEET EAST FROM SW CORNER SECTION 36; POINT 3 - 910 FEET NORTH & 140 FEET EAST FROM CENTER SECTION 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-SIXTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season March 1 to September 1 of each year.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm an ADDITIONAL POINT OF DIVERSION and a change in PLACE OF USE approved by an order of the Water Resources Director entered DECEMBER 20, 1979, and supersedes certificate 135, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
